ARTICLE VII SECTION 7.1 D3a

- vi. Be designed based on a four-foot minimum separation between the bed bottom and average seasonal high water table levels. Slope averaging shall not be allowed. (Adopted 05/1994)

Where expansion of use requires modifications to septic systems on existing lots not meeting the criteria contained herein, an applicant shall have the right to request a waiver be granted by the Board of Health.
