1pm. A pre-bid meeting will be held at 6:30pm on Wednesday, March 20<sup>th</sup>, 2019 at the Pinnacle Leadership Center located at 199 South Road, Kensington. A site walkthrough will be held at Sawyer Park and Field on Thursday, March 21<sup>st</sup>, 2019 at 12 noon. It is strongly suggested all bidders to attend. Motion made to accept modified contract by Mike. 2<sup>nd</sup> by Glenn. Unanimous.

Sawyer Park and Field Turf Care Specifications contract were modified to one year contract along with timeline of the Maintenance contract above. Motion made to accept modified contract by Mike. 2<sup>nd</sup> by Glenn. Unanimous.

A motion was made to send both the Sawyer Park and Field Maintenance Specifications contract and the Sawyer Park and Field Turf Care Specifications contract to the BOS by Mike. 2<sup>nd</sup> by Glenn. Unanimous.
