**Summer Camp 2023:** This meeting primarily focused on the summer camp planning. Stephanie confirmed that John Lebel (Kensington FF/AEMT) will host a First Aid & CPR training for the incoming camp staff. The date of this training is TBD, and Stephanie will coordinate with both Chief True and John Lebel. Lili is working to complete the KES building usage form, to ensure the camp will have access to KES as needed. Sarah Turcott (not in attendance) confirmed prior to the meeting that she is working to complete the online registration and payment system. Stephanie is planning to visit the supply bunker at Sawyer Park for clean-out and inventory purposes. We discussed and approved Stephanie to schedule "meet and greet" and in-person registrations while she is at the Park, April 18th, 5:00-6:30 pm, and again on April 22nd, 10:30 am-12:30 pm. KRSC members reviewed and approved the camp brochures and job posting fliers that Stephanie created. We discussed the applications already received for both Counselor and CIT positions, and Stephanie will move forward with scheduling interviews in the upcoming weeks, ensuring at least one KRSC member is in attendance. Jessica to confirm the Town Hall is available for interview use, during the days/ times discussed during this meeting. A motion was made to allow Stephanie's 13 year old son to attend random camp days at no charge, as he will be assisting his mother and will be a helper at the camp.

**Senior Tea:** The next senior social tea/ coffee is scheduled for April 19th, 10-11:30 am at the Town Hall. Barbara Greenwood was alerted to this date, to gauge her interest in involving the Kindergarten children to participate in some capacity. An additional senior tea was also scheduled for May 17th for 10-11:30 am, to be held at The Grange.

**Old Home Day (OHD):** The Sawyer Park Trust previously confirmed the OHD event to occur Aug 19th. An email was provided to the various town organizations and committees, to attend a meeting at the Town Hall on May 4th at 5:30 pm, to kick start the event planning. Anyone who is interested in being involved in planning/ volunteering/ participating in this event, is welcome to attend the meeting.

**Other Business:** Committee members voted in agreement to sponsor the KES 2023 yearbook with a \$100 donation. Sponsorship includes providing pictures of the various KRSC events throughout the year to be included in the yearbook.
