## ADOPT-A-VISIBILITY-SITE GROUP AGREEMENT STATEMENT OF VOLUNTEER ACTIVITY

The Town of Kensington, New Hampshire, having offices at 95 Amesbury Road Kensington, NH, herein after called the TOWN and the Individual, whose name and address are:

Herein after called the Group, hereby enter into this agreement, which provides that the Group shall maintain \_\_\_\_\_\_in the Town of Kensington described as follows:

The Group acknowledges the hazardous nature of the activity and agrees to the following terms and conditions:

- 1. A Town official shall conduct an initial safety briefing for the individual as part of a general ori entation and expectation over the area being maintained.
- 2. The participants shall wear an approved safety vest.
- 3. The group and its members understand completely that there is no provision, expectation or future receipt of compensation by the Town of Kensington for his/her voluntary efforts
- 4. Unless modified by the Town, the Group shall conduct operations no less than once a month, and to assist with monitoring the program, shall call the Kensington police department upon completion of each activity. The police department's telephone number is 772-2929.

- 5. The Group agrees to participate in an initial interview/screening process to ensure volunteers are capable and understanding of the nature of the activity being volunteered for.
- 6. The Group will organize and supervise all activities.
- 7. No work of any nature will be performed on the pavement or shoulders of the traveled way.

- 9. No participant's vehicle may be parked on the travel lanes or shoulders.
- 10. Each Group participant shall sign and ate the General Release form which shall be kept on file at the Town of Kensington for the duration of the work. The Group will provide a certificate of insurance covering the Group and its volunteers.
- 11. The Town will furnish and erect the Adopt a Visibility Sight Sign in the specified area.

Notwithstanding any other provision of this Agreement, if in the sole judgment of the Town it is determined that the Group is not meeting the terms and conditions of this agreement, or summarily if based upon unsafe activity, the Town may terminate this Agreement upon written notice to the Group.

The Group shall be required to seek permission from the Town of Kensington before any site modifications occur. Such site modifications may include, but are not limited to, planting of new trees, installing new features, painting landscape structures or planting other monuments. The Town recognizes the Group as the adopting organization for a segment or area, and the Group accepts the responsibility of maintaining, which includes regular watering and weeding if necessary of the adopted segment of the term and limits of this agreement.
