Pursuant to Chapter 20:6 of the Laws of 2017, the Kensington Board of Selectmen will conduct a public hearing on Monday, May 8, 2017 at 6:30 p.m. at the Kensington TOWN HALL, 95 AMESBURY ROAD, whether the Board of Selectmen, as the governing body, shall legalize, ratify, and confirm all actions, votes and proceedings held at the Town Meeting scheduled for March 14, 2017, but postponed to March 16, 2017 due to weather. This process is in accordance with ratification process set forth in Chapter 20:6 of the Laws of 2017.
2. *Pursuant to the provisions of RSA 36-A:4 and RSA 675:7, the Kensington Board of Selectmen will conduct a public hearing on Monday, May 8, 2017 at 6:30 p.m. at the Kensington TOWN HALL, 95 AMESBURY ROAD, concerning the acceptance of a Secondary Executory Interest in a proposed Conservation Easement which would encumber approximately 210-acres of the property identified as Tax Map 7, Lots 8 & 14 and Tax Map 10, Lots 14 & 19, located along Stumpfield Road.*

The Board of Selectmen will hold a public hearing on Monday May 8, 2017 at 6:30pm in the Kensington Town Hall, 95 Amesbury Road, for one application in Kensington for a Discretionary Preservation Barn Easement in accordance with RSA 79-D, Historic Barn Tax Incentive Program. This application is a renewal of a previously approved easement.
