### **Town of Kensington Rolls out New Single-Sort Recycling Program**

**Kensington, NH (Aug. 9, 2021)** – The Town of Kensington will begin rolling out new recycling carts for residents next week as it launches its “single-stream” collection service.

With this new recycling program, Town residents will be able to place all recyclable items directly into a new, larger recycling container. The 65-gallon carts will begin arriving at residents’ homes in August 2021 with collection beginning later this month. The carts will replace the smaller recycling bins currently used for residential recycling and come with wheels for easy maneuvering and attached lids to keep recyclables dry and secure.

The Town applied for and received a grant from The Recycling Partnership, a nonprofit organization that works with communities nationwide to transform their recycling programs. The Town of Kensington was selected to receive grant support because of its dedication to advancing recycling in the community. The grant from The Recycling Partnership helped pay for 807 new carts and includes funding for education and outreach about the new collection process.

“The Recycling Partnership is proud to partner with the Town of Kensington to expand equitable recycling access for the Kensington’s nearly 807 households,” said Chris Coady, Director of Community Programs at The Recycling Partnership. “We are thrilled to help the Town capture an estimated 50,000 pounds of quality recyclables, unlocking critical supply for the circular economy and local manufacturers.”

The Town asks that residents continue to do their part by placing only recyclable materials in their carts, including glass bottles and jars, aluminum and steel cans, food and beverage cartons, paper products (including newspapers and flattened cardboard), and empty plastic bottles and containers. To help limit trash in recycling carts, only place empty and dry items directly into the recycling cart.

Some items that cannot be recycled in curbside carts include plastic bags, paper towels, pizza boxes, electrical equipment, batteries, and clothing. These items often get mixed into recycling carts because of “wishcycling,” or the hope that they can be recycled. While well-intentioned, non-recyclable items cause serious safety issues for recycling personnel.
